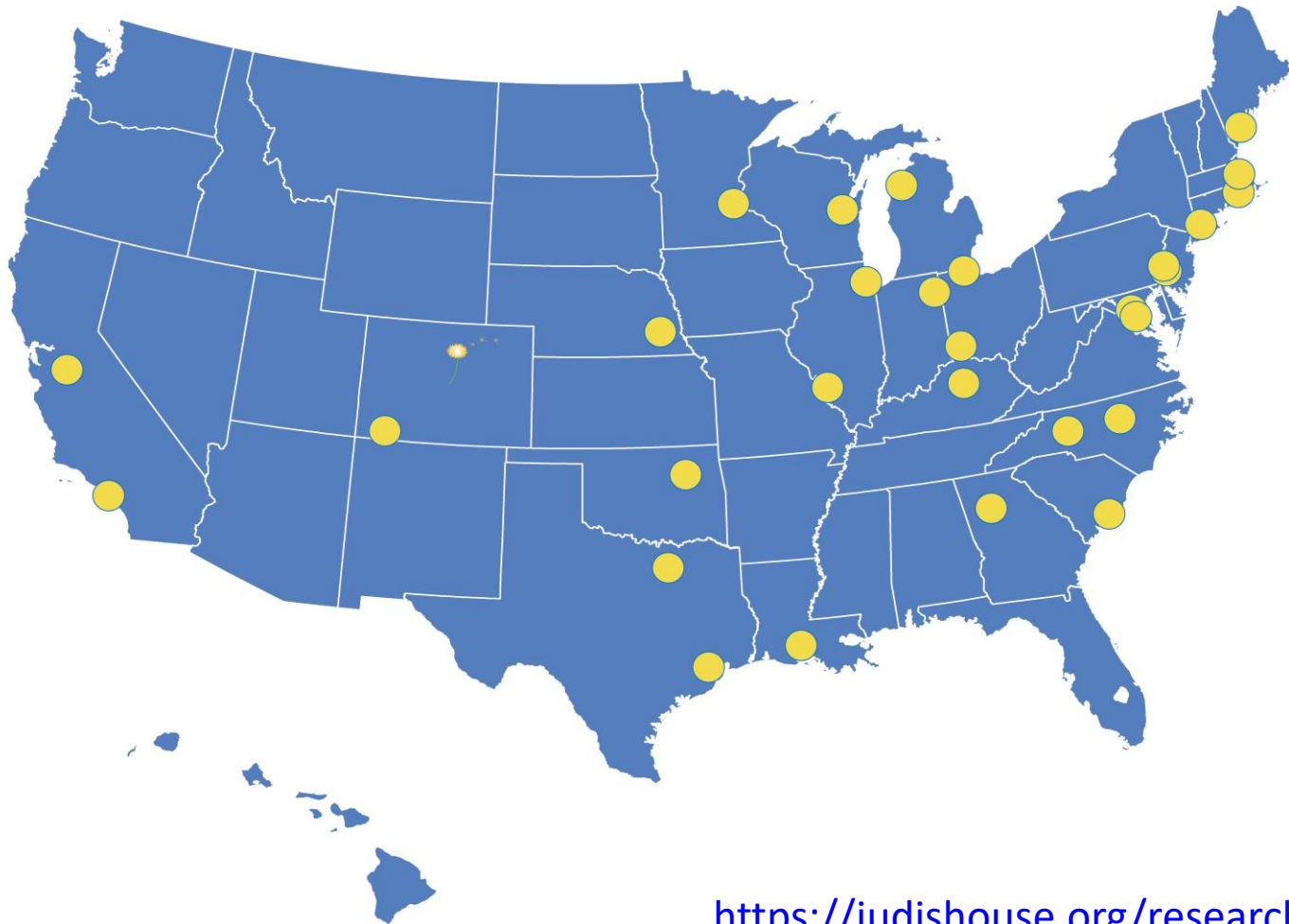

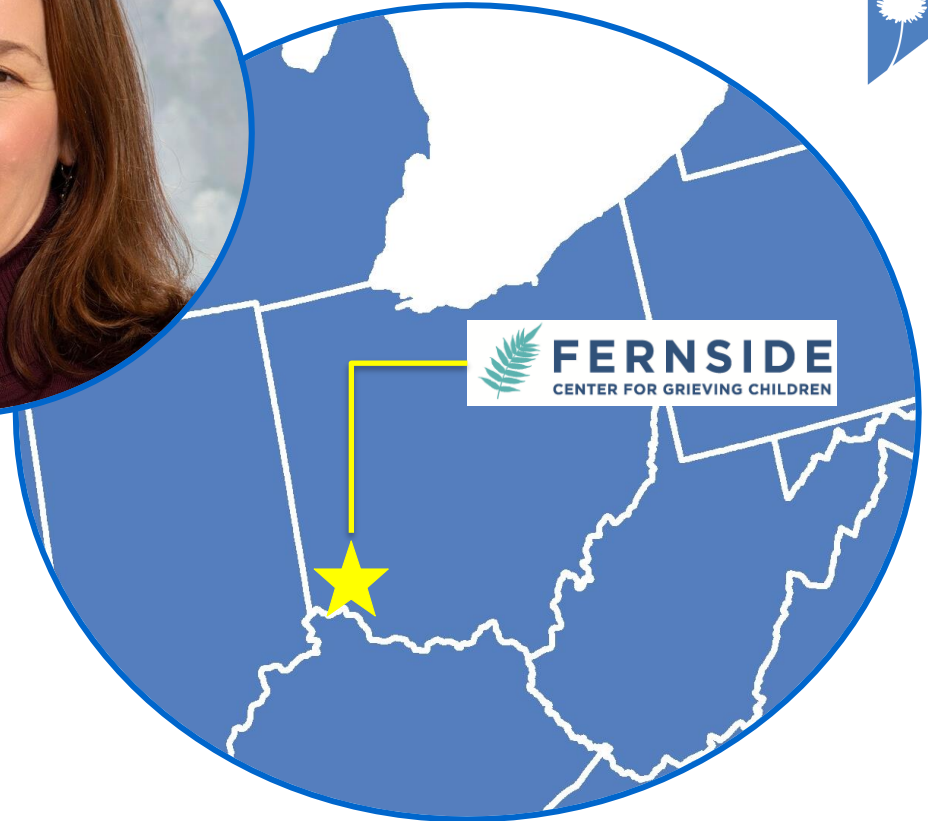

CBC Initiative Goals

- **Provide resources to implement tested, low-cost approaches to data collection that can answer questions such as:**
 - Who are we serving?
 - Who are we *not* serving?
 - What difference does our program make?
 - How can we better tell our story?
- **Initiate best practice standards for evaluation and data collection/utilization**

***CBC* Initiative Elements**

- **Sequenced evaluation training model (per module)**
 - Interactive Workshop (2 hours)
 - Individual Assistance Sessions (Up to three 1-hour sessions)
 - Group Assistance Session (2 hours)
- **Network of partners and collaborators**
- ***Changemaker* Cohorts**

CBC Modules

Module 1: Preparation

- Support *Changemakers* in basic process and outcome evaluation, including:
 - Capacity assessment
 - Stakeholder engagement
 - Defining your model
 - Setting goals and identifying barriers
 - Initial development of evaluation plan

CBC Modules

Module 2: Planning & Implementation

- Will prepare *Changemakers* to:
 - Select initial data to collect
 - Create protocols
 - Design a data management framework
 - Plan for data analysis and reporting
 - Implement data collection

CBC Modules

Module 3: Data Cleaning & Analysis

- Will prepare *Changemakers* for:
 - Data capture and cleaning
 - Analysis
 - Interpretation
 - Reporting

CBC Modules

Module 4: Utilization/Reflection

- Will support *Changemakers* in utilizing data, including:
 - Planning for internal data discussions
 - Surfacing learnings
 - Adjusting data collection plans
 - Making data-informed decisions
 - Telling your story of impact to stakeholders
 - Finalizing evaluation plan
