AWARENESS AND FIELD ADVANCEMENT - THE NACG SERVES AS THE LEADER AND CONDUIT FOR NATIONAL AWARENESS AND FIELD ADVANCEMENT FOR THE CHILDREN'S BEREAVEMENT SUPPORT FIELD. THE NACG PROVIDES NATIONAL STANDARDS OF PRACTICE FOR THE CHILDREN'S BEREAVEMENT SUPPORT FIELD, COORDINATES ANNUAL SOCIAL MEDIA AND ON-LINE ACTIVITIES FOR CHILDREN'S GRIEF AWARENESS MONTH IN NOVEMBER, AND COMPILES RESEARCH AND INFORMATION REGARDING CHILDREN'S GRIEF SUPPORT FOR EASY ACCESS TO PROFESSIONALS AND VOLUNTEERS IN THE FIELD. THE NACG ALSO PROVIDES A NATIONAL DATABASE OF ORGANIZATIONS AND PROGRAMS PROVIDING CHILDREN'S BEREAVEMENT SUPPORT ACROSS THE AMERICA, INCLUDING GRIEF CENTERS, BEREAVEMENT CAMPS, SUPPORT GROUPS, INDIVIDUAL AND FAMILY COUNSELING, AND BEREAVEMENT SUPPORT.

ANNUAL FEES ARE KEPT LOW, WITH MEMBERSHIP OPPORTUNITIES RANGING FROM \$60 TO \$100 PER YEAR. IN 2024, WE CONTINUED OUR MEMBER NETWORKING OPPORTUNITIES WITH 110 MEMBER CONNECTION AND NETWORKING CALLS FOR OUR MEMBERS IN AN EFFORT TO OFFER PEER SUPPORT AND WITH THE GOAL TO KEEP OUR FIELD CONNECTED AND SUPPORTED.
